## Permanent Sign Application

*No sign shall be permitted in any zoning district except as an accessory use and in full compliance with Chapter 27, Article 17, Signs, of the Elizabeth Township Zoning Ordinance 820, as amended.*

The following information must accompany **ALL** sign permit applications:

- A full description of the proposed sign, a description of the lot on which the proposed sign will be located, and a description of any other existing signs on the same lot.
- Two (2) copies of a drawing showing: The width, height, gross surface area, total height above adjacent ground level, clearance between bottom most part of the sign and ground level, distance between front edge of sign and adjacent street or right-of-way, and distance between front edge of sign and inside edge of adjacent sidewalk, if applicable, of the sign.
